Develop jobs that manage the generation and processing of data files to/from the core system; Implement and maintain Symitar core processing applications and related software systems and applications.

Research available tools and technologies to determine alternative technology solutions.

Develop, implement, and maintain routine to complex software applications using multiple technologies, platforms, and interfaces.

Modify acquired application software using vendor supplied customization tools to implement approved changes specified by end users and/or management.
