With increasing complexities, evaluates the adequacy and effectiveness of the internal controls of the branch and credit union department activities, gathers and analyzes data, and reports audit results to management in accordance with Standards for the Professional Practice issued by the Institute of Internal Auditors.</p> <p>E 10% Coordinates and assists external auditors and NCUA examiners with research and testing of audit programs and examinations.</p> <p>E 10% Stay current on professional and credit union industry regulations, reporting requirements, auditing procedures, and general accounting principles or auditing techniques, by attending continuing education classes, webinars, as well as reading professional periodicals/journals.</p> <p>E 10% Assist Staff Internal Auditor(s) with branch/functional audits/reviews when needed</p> <p>E 5% Reviews and investigates member complaints under supervision of the AVP for the Supervisory Committee and the NCUA. Assists the AVP in drafting a formal response for review and approval by the Chair of the Supervisory Committee.</p> <p>N 5% Performs other duties as assigned.</p> <p>Performance Measurements:</p>
