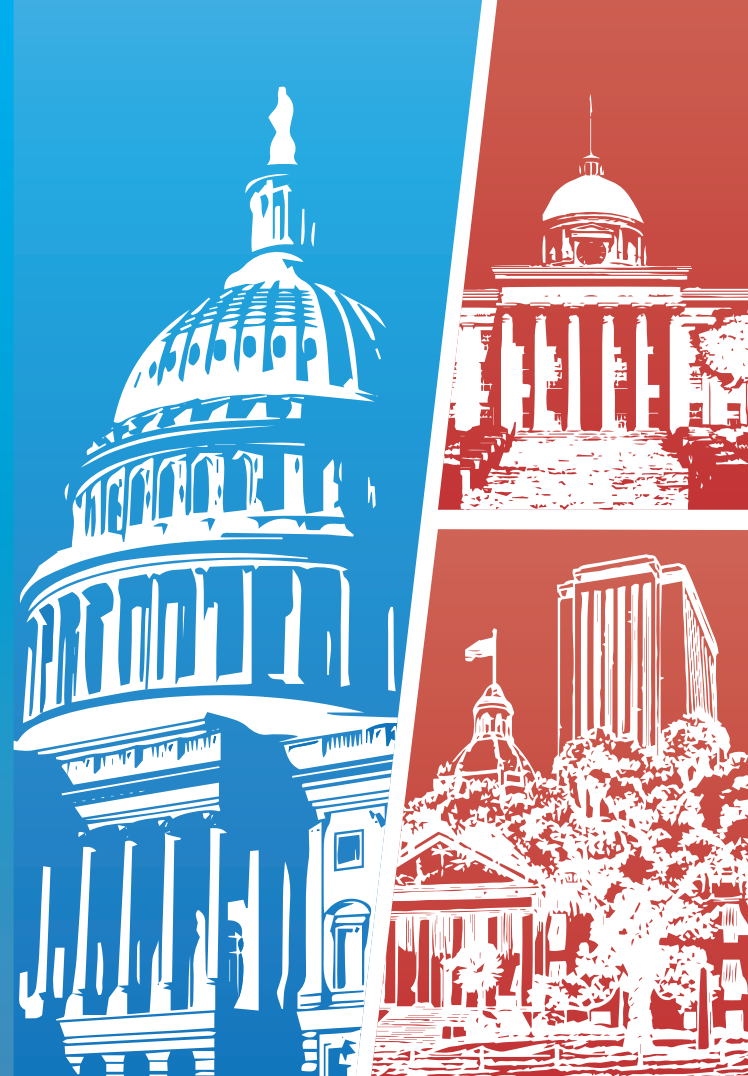

## What is a Political Action Committee?

# PAC

Political action committees (PACs) are non-profit, bipartisan organizations that raise funds to support candidates on behalf of an industry at the State and Federal levels.

Credit unions exist to serve their membership. To continue to do so, we need to have elected officials that understand credit union issues and support the credit union movement. Contributions to LSCU PACs help elect credit union friendly candidates and build relationships with policy makers and ensure that credit unions have a voice on the state and national level. Simply put, the stronger credit unions are politically, the stronger credit unions are legislatively.

### GIVE:

- Being active in political giving is a personal investment in your credit union. Every new financial regulation that is passed in Washington, Montgomery or Tallahassee may affect the credit union movement and the way your credit union operates.
- Contributing to an LSCU PAC gives your credit union a voice in the electoral and legislative process
- Your PAC contribution ensures that credit union friendly candidates that believe in the credit union movement get elected and stay in office.

- By contributing to the PACs, you are helping the credit union industry collectively to advocate for better operating environment.

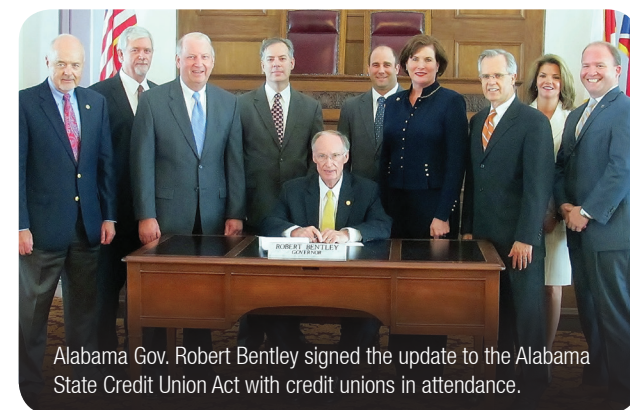
### Grow:

#### **ACULAC**

Alabama Credit Union Legislative Action Council (ACULAC) is the LSCUs state registered political action committees (PAC). ACULAC makes contributions to candidates for the Alabama Legislature and other statewide elective offices.

#### **CUPAC**

Florida Credit Union Political Action Committee (CUPAC) is the LSCUs state registered political action committee (PAC). CUPAC makes contributions to candidates for the Florida Legislature and other statewide elective offices.
