LSCU Honors Florida Congresswoman Kat Cammack as 2023 Federal Lawmaker of the Year

First elected to Congress in 2021, Rep. Her district includes a number of largely rural counties in North Central Florida, and her childhood on a small cattle ranch in Colorado gives her a unique perspective and penchant to partner with credit unions in advancing underserved communities.
