LSCU Advocacy Teams Begin Year with Legislative Session

Florida, Alabama and Georgia all begin 2020 with a focus on legislative session. Georgia's legislative session is slated to run from January 13th through mid to late April possibly. Florida's legislative session will start on January 14th and run 60 consecutive days until March 13, provided the budget is complete and voted on. Finally, Alabama's legislative session will run for 100 calendar days starting on February 4th and lasting until May 15th. During these periods your Advocacy Teams are vigilant against anti-credit union legislation, and work hard to push our agenda forward, promoting the credit union movement as well as any supporting policies. Each state will outline important issues in their respective session previews. Trusted advocates are asked to be on the ready in the event any issue comes to a head and call(s) to action are warranted.
